### **1. Welcome Introductions**

*Mr. Sigüenza wanted to ensure that everything that was covered was fully understood by his part. He asked about student academic levels. Mrs. Ramos reemphasized the key points and services provided. Mr. Sigüenza then expressed his appreciation for all the efforts towards the students and parents.*
